- 9 COG seeks an order pooling additional
- 10 uncommitted interest under the terms of Order
- 11 Number R-22904 which pooled interest in the Coral
- 12 Canyon Bone Spring South pool underlying a 280-acre
- 13 standard horizontal spacing unit comprised of the
- 14 west half of the west half of Section 5 and the west
- 15 half northwest quarter and northwest quarter of the
- 16 southwest quarter of Section 8, Township 26 South,
- 17 Range 29 East in Eddy County.
- 18 The order dedicated the unit to the
- 19 Hambone Federal Com 506H well and designated the
- 20 applicant as operator of the unit and the well.
- 21 Since the order was entered COG determined
- 22 that additional uncommitted interest owners should
- 23 be pooled under the terms of the order.
- We've provided the affidavit of landman
- 25 Hunter Hall in support of the application. The

- 1 tract ownership information is included in

- 5 Marathon.

- 8 both of those parties.

- 10 request that the exhibits be admitted and that the
- 11 case be taken under advisement.

- 25 the time.
