1 HEARING OFFICER BRANCARD: All right. I'm

- on Item Number 26. This is case 22845, Tap Rock
- 3 Operating.
- 4 MR. RODRIGUEZ: Good morning. Michael
- 5 Rodriguez with Tap Rock Operating, LLC.
- 6 HEARING OFFICER BRANCARD: Thank you,
- 7 Mr. Rodriguez.
- I have EOG Resources.
- 9 MR. FELDERWERT: Good morning,
- 10 Mr. Examiner, Michael Feldewert with the Santa Fe
- 11 office of Holland & Hart.
- 12 HEARING OFFICER BRANCARD: Marathon Oil
- 13 Permian.
- MS. BENNETT: Good morning, Mr. Examiner,
- 15 Deana Bennett on behalf of Marathon Oil Permian,
- 16 LLC.
- 17 HEARING OFFICER BRANCARD: And,
- 18 Ms. Bennett, Marathon has filed an objection to this
- 19 case going forward by affidavit?
- 20 MS. BENNETT: That's correct. And I also
- 21 understand that EOG may be filing some competing
- 22 applications and I'll differ to EOG on that. So,
- 23 but, yes, Marathon did file an objection to the case
- 24 proceeding by affidavit.
- 25 HEARING OFFICER BRANCARD: Thank you.

1 Is Marathon planning on filing

- 2 applications?
- 3 MS. BENNETT: I don't have that
- 4 information right now, Mr. Examiner, but I'm happy
- 5 to find that out. But it was my understanding that
- 6 because EOG was planning on filing competing
- 7 applications, that EOG had an interest in having
- 8 this case and EOG's competing applications be -- or
- 9 EOG had an independent reason for having these cases
- 10 continued, which is why I did not -- or this case
- 11 continued, which is why I haven't yet followed up
- 12 with Marathon.
- 13 HEARING OFFICER BRANCARD: Thank you.
- 14 Let's try you, Mr. Feldewert, EOG's
- 15 position.
- MR. FELDEVERT: Thank you, Mr. Examiner.
- 17 EOG has sent out recently competing well
- 18 proposals. They do involve the same acreage that's
- 19 involved here. They will -- my anticipation is that
- 20 those cases, if the parties do not reach an
- 21 agreement that the cases will be filed for the
- 22 August 4th docket, so they will appear on the
- 23 August 4th docket.
- 24 My suggestion is that we set August 4th
- 25 for a status conference since you'll have these

1 cases and then the Tap Rock cases on the docket at

- 2 that point in time and figure out where we are and
- 3 determine if we need to have a contested hearing.
- 4 HEARING OFFICER BRANCARD: Thank you.
- 5 Mr. Rodriguez, back to you.
- 6 MR. RODRIGUEZ: Thank you. So it's my
- 7 understanding that the parties are currently in
- 8 discussion to resolve their differences. However,
- 9 this is a high priority project for Tap Rock and
- 10 it's eager to develop its acreage. And so we would
- 11 schedule -- we would request that the Division
- 12 schedule these matters for their earliest contested
- 13 hearing date available in light of those
- 14 considerations. If we did set a contested
- 15 hearing -- I'm sorry, a status conference on
- 16 August 4th, we just request that if this matter was
- 17 set for a contested hearing that it would be
- 18 sometime, maybe the second docket in August, which
- 19 would be August 18th.
- 20 HEARING OFFICER BRANCARD: Well, I think
- 21 if we have a status conference on August 4th, we're
- 22 not going to have a hearing on August 18th, it would
- 23 be sometime later than that. So the issue is
- 24 whether to set this as a status conference or a
- 25 contested hearing.

1 Mr. Feldewert, I think you seem to be

- 2 hopeful this might get concluded?
- 3 MR. FELDEVERT: Well, I'm hopeful,
- 4 obviously. You know, I've been hopeful before, but
- 5 so, you know, I don't -- I understand
- 6 Mr. Rodriguez's position. I think I leave it up to
- 7 you, Mr. Examiner, and Mr. Rodriguez if we really
- 8 think we need a contested hearing set at this point
- 9 in time. I understand that, if that's -- if that's
- 10 what they think they need.
- 11 HEARING OFFICER BRANCARD: Ms. Bennett, do
- 12 you have a position on timing?
- MS. BENNETT: Not per se, although I was
- 14 under the impression that the cases would at least
- 15 be continued to August 4th for EOG to file its
- 16 competing applications.
- 17 HEARING OFFICER BRANCARD: Okay.
- 18 Mr. Feldewert, can you get your cases filed by then?
- 19 MR. FELDEVERT: Yes, Mr. Examiner. You
- 20 know there's more than one -- there's more parties
- 21 involved than just three on the phone here today, or
- 22 the Webex. We anticipate filing the applications
- 23 for the August 4th docket, so they will be on the
- 24 August 4th docket.
- 25 HEARING OFFICER BRANCARD: Okay. So we

Page 7 will set this for a hearing on August 4th. 1 Mr. Feldewert, whenever you file your cases, please 2 3 let us know so we can amend the prehearing order to add them in. 4 Certainly. 5 MR. FELDEVERT: HEARING OFFICER BRANCARD: And then if the 6 7 parties are in the midst of negotiations, you can 8 always turn August 4th into a status conference. 9 MR. RODRIGUEZ: Sounds good. Thank you. 10 MS. BENNETT: Thank you. 11 MR. FELDEVERT: Thank you, Mr. Examiner. 12 (Matter concluded.) 13 14 15 16 17 18 19 20 21 22 23
