1 HEARING EXAMINER BRANCARD: We are looking at

- 2 cases now that are continued from prior hearings, Item 32,
- 3 Case 22673, Mewbourne Oil Company.
- 4 MR. BRUCE: Mr. Examiner, Jim Bruce here for
- 5 Mewbourne.
- 6 HEARING EXAMINER BRANCARD: Are there any other
- 7 persons here for Case 22673?
- 8 MR. SAVAGE: Mr. Examiner, Darin Savage with
- 9 Abadie & Schill on behalf of Cotera Energy, Cimarex Energy
- 10 Company.
- 11 HEARING EXAMINER BRANCARD: Any other persons for
- 12 Case 22673?
- 13 (No audible response.)
- 14 HEARING EXAMINER BRANCARD: Hearing none, Mr.
- 15 Bruce, I think there were a few items here --
- MR. BRUCE: Yes, sir.
- 17 HEARING EXAMINER BRANCARD: -- that we needed
- 18 from you.
- 19 MR. BRUCE: Yes. First of all, I think one of
- 20 the main reasons for the continuance was that this is in the
- 21 Brine Well area, but I previously e-mailed you, and I think
- 22 it was Mr. Rose-Coss, that this particular well is covered
- 23 by that Brine Well order that was entered, oh, several
- 24 months ago.
- 25 HEARING EXAMINER BRANCARD: I have, I have, you

1 know, mentioned this internally and have not heard any loud

- 2 shrieks or howls, so I think, yeah, one option then is to
- 3 have this order simply reference that file.
- 4 MR. BRUCE: Correct.
- 5 HEARING EXAMINER BRANCARD: Because the well --
- 6 the wells that are in this order are wells that are covered
- 7 by that order.
- 8 MR. BRUCE: Correct. The other thing was, this
- 9 matter only force pooled the record title owner for purposes
- 10 of obtaining a communitization agreement, getting a
- 11 communitization agreement by the State Land Office.
- 12 But the examiners at the -- I did not -- because
- 13 of that, I did not present geology, but unfortunately it
- 14 wasn't until yesterday I did submit some supplemental
- 15 exhibits, first of all, a geology affidavit justifying the
- 16 well unit, so that was done.
- 17 And the second item was I did submit supplemental
- 18 exhibits yesterday, and also contained in that were, was a
- 19 land plat which was requested showing the tracts involved in
- 20 the well unit, and specifically identifying the tracts in
- 21 which the record title owner owns an interest.
- 22 And finally I -- that's what I had on my list,
- 23 anyway, and I thought I took care of everything, but if
- 24 there is another thing on your list, I can certainly look
- 25 into taking care of that. But I would move the admission of

1 supplemental Exhibits 6 and 7 which were filed, albeit late.

- 2 HEARING EXAMINER BRANCARD: Any objection, Mr.
- 3 Savage?
- 4 MR. SAVAGE: Mr. Brancard, I apologize, I jumped
- 5 into the case too early. I will withdraw my appearance.
- 6 Thank you.
- 7 HEARING EXAMINER BRANCARD: You had me going
- 8 there.
- 9 MR. SAVAGE: Had me going, too.
- 10 HEARING EXAMINER BRANCARD: Okay, the exhibits
- 11 will bed admitted into the record. The only thing I noted,
- 12 Mr. Bruce, another technicality here, you just need to
- 13 resubmit the checklist with your signature on it.
- MR. BRUCE: Oh, that's right, that's right. I
- 15 will do that later today.
- 16 HEARING EXAMINER BRANCARD: Thank you. Mr.
- 17 McClure, any questions?
- 18 TECHNICAL EXAMINER McCLURE: No questions for
- 19 this case, Mr. Brancard.
- 20 HEARING EXAMINER BRANCARD: And Mr. Bruce, I do
- 21 not know what the status of the Brine well order is. I know
- 22 that there has been numerous internal discussions about
- 23 coming up with clarification on that, but I am not privy to
- 24 what the latest is. I'm sure your clients will find out.
- 25 MR. BRUCE: Understood. And as I, I think I --

Page 6 well, I might have mentioned it in the e-mail to you and Mr. 2 Rose-Coss, there is a question as to whether the well has been drilled. It has been drilled, but not completed 3 pending the Brine well issue. 5 HEARING EXAMINER BRANCARD: Right, right. And that order, the other order that we are referencing did note 6 that some wells were drilled, but not completed. 8 MR. BRUCE: Correct. 9 HEARING EXAMINER BRANCARD: All right. Thank 10 you. Is there anything else here right now on Case 22673? (No audible response.) 11 12 HEARING EXAMINER BRANCARD: If not, the exhibits 13 will be admitted into the record and the case will be taken 14 under advisement. MR.
