1 HEARING EXAMINER BRANCARD: With that we are on

- 2 Item 62, Case 22860, Catena Resource Operating.
- 3 MS. McLEAN: Jackie McLean with Hinkle Shanor on
- 4 behalf of Catena.
- 5 HEARING EXAMINER BRANCARD: Are there any other
- 6 interested appearances for Case 22860?
- 7 (No audible response.)
- 8 HEARING EXAMINER BRANCARD: Hearing none, please
- 9 proceed, Ms. McLean.
- 10 MS. McLEAN: Thank you, in Case 22860, Catena
- 11 seeks an order pooling additional uncommitted interests
- 12 under the terms of Division Order Number R-22131. On May 9,
- 13 2022, the Division entered Order Number R-22131 in case
- 14 Number 22630 which pooled all uncommitted interest in the
- 15 Scharb Wolfcamp Pool within the Wolfcamp formation,
- 16 underlying a 640 acre horizontal spacing unit, comprised of
- 17 the E/2 of Section 5, Township 19 South, Range 35 East, and
- 18 the E/2 of Section 32, Township 18 South, Range 35 East in
- 19 Lea County, New Mexico.
- 20 And the order dedicated the unit to the Foxtail
- 21 E2 05 32 W1 State Com 1H well and designated Catena as the
- 22 operator. Now following the entry of the order, Catena
- 23 identified an additional uncommitted interest to the unit
- 24 that should be pooled under the terms of Order Number
- 25 R-22131.

1 And the exhibit packet submitted to the Division

- 2 contains Exhibit A, which is the land professional's
- 3 testimony and related land exhibits, the Order R-22131 which
- 4 we seek to amend, and the plat of tract ownership interest
- 5 and uncommitted interests to be pooled as well as the sample
- 6 well proposal letters, AFE and chronology of contacts.
- 7 And then Exhibit B is a notice affidavit which
- 8 sets out when the notice letter of this hearing and
- 9 application was sent to all the interested parties, as well
- 10 as a chart which sets out the date that everything was
- 11 mailed and the date we received the return, with the
- 12 supporting green cards to support that chart.
- And then finally Exhibit D-3, which is the notice
- 14 affidavit showing that we timely published in the Hobbs News
- 15 Sun on June 17, 2022.
- 16 And with that, unless there are any questions, I
- 17 ask that the exhibits be admitted into the record and that
- 18 Case Number 22860 be taken under advisement.
- 19 HEARING EXAMINER BRANCARD: Thank you. Mr.
- 20 McClure?
- 21 TECHNICAL EXAMINER McCLURE: No questions for
- 22 this case, Mr. Brancard.
- 23 HEARING EXAMINER BRANCARD: Okay, Ms.
- 24 McLean, here is the problem, this involves E/2 of Section 5
- of one township, and then the E/2 of Section 32 which is in

- 1 a different township. That's all correct in your
- 2 application and checklist, but in the notice paragraph that
- 3 was submitted, which you had published also in the newspaper
- 4 notification, it indicates that Section 5 and 32 are in the
- 5 same township.
- 6 MS. McLEAN: I see that. And then, yeah, their
- 7 application is correct, so our notice appears to be
- 8 incorrect.
- 9 HEARING EXAMINER BRANCARD: Okay. So we've got
- 10 two notice problems, one in the newspaper notice and the
- 11 other is notice paragraph you submit to Hobbs which then
- 12 goes into our official notice and you know that docketed
- 13 publication.
- MS. McLEAN: Right.
- 15 HEARING EXAMINER BRANCARD: So you need to submit
- 16 a new paragraph with the correct legal description. As far
- 17 as the newspaper notice, it seems you are only notifying two
- 18 parties.
- MS. McLEAN: That's correct.
- 20 HEARING EXAMINER BRANCARD: You seem to have
- 21 gotten the green card back from one party, but not from the
- 22 second party.
- 23 MS. McLEAN: That's correct. And we checked the
- 24 USPS tracking, and it said "in transit to next facility,"
- 25 and the last update we have received on that was June 10, so

- 1 I don't really know what that means.
- 2 HEARING EXAMINER BRANCARD: I don't know. I
- 3 mean, if you got the green card back, then you don't need
- 4 the newspaper --
- 5 MS. McLEAN: Correct.
- 6 HEARING EXAMINER BRANCARD: So we are going to
- 7 continue this case so we can get our docket sheet have the
- 8 correct paragraph which you will provide to us. And then
- 9 you either provide a new newspaper notification or we will
- 10 we will wait until you get a green card.
- MS. McLEAN: We will continue it and then we will
- 12 probably republish unless, you know, something miraculously
- 13 appears.
- 14 HEARING EXAMINER BRANCARD: All right. So why
- 15 don't we then -- August 4, is that enough time?
- 16 MS. McLEAN: That should give us enough time to
- 17 get the publication notice out.
- 18 HEARING EXAMINER BRANCARD: So we will continue
- 19 this case to August 4 to resolve the notice issues, and you
- 20 should file a continuance with us. And you should
- 21 immediately get us the correct paragraph so we can put that
- 22 in our docket sheet.
- 23 MS. McLEAN: Yes, we will do that. Thank you.
- 24 HEARING EXAMINER BRANCARD: Thank you. Are there
- any other comments in Case 22860?

Page 7 (No audible response.) HEARING EXAMINER BRANCARD: The case will be continued to August 4. The exhibits that were submitted today will be admitted into the record. MS. McLEAN: Thank you. (Exhibits admitted.) (Continued.)
