1 HEARING EXAMINER BRANCARD: Today is July 7, 2022

- 2 hearing of the Oil Conservation Division. So the question
- 3 is, where are we? I believe there was some -- I put here,
- 4 should we shuffle the deck a bit and try to move ahead with
- 5 Item Number 79, Case 22920? Is that correct?
- 6 MR. FELDEWERT: Yes, Mr. Brancard, I requested
- 7 that at lunch, and yeah, I just got an e-mail from Jim Bruce
- 8 saying he didn't object, so if that case could proceed, that
- 9 would allow Ms. Broggi to get to an appointment that she has
- 10 early this afternoon.
- 11 HEARING EXAMINER BRANCARD: So with that, we will
- move to Item Number 79 on today's list, Case 22920, Spur
- 13 Energy Partners.
- 14 Ms. Broggi, I believe you are muted.
- 15 MS. BROGGI: Mr. Examiner, thank you for allowing
- 16 us to cut in line a little bit. Julia Broggi with the
- 17 Santa Fe office of Holland & Hart on behalf of the applicant
- 18 Spur Energy Partners.
- 19 HEARING EXAMINER BRANCARD: Thank you. Are there
- 20 any other interested persons for Case 22920?
- 21 (No audible response.)
- 22 HEARING EXAMINER BRANCARD: Hearing none, Ms.
- 23 Broggi, you may proceed.
- MS. BROGGI: Thank you. Before I turn to the
- 25 evidence, I wanted to remind the Division of the procedural

- 1 posture of this case which is a little bit unusual.
- 2 So there was an initial case which was 21588, and
- 3 it resulted in Division Order Number 21578, which was
- 4 entered back in January of 2021. And that basically created
- 5 a 320 acre horizontal spacing unit in the E/2 of Section 7,
- 6 Township 19 South, Range 25 East, Eddy County, New Mexico,
- 7 and it pooled the uncommitted interest in the entire Yeso
- 8 formation.
- 9 In the intervening time, you may recall that we
- 10 reevaluated it and decided it was more prudent to increase
- 11 the horizontal spacing unit by 160 acres to basically
- 12 include the SE/4 of Section 6, so it's just right north of
- 13 that initial horizontal spacing unit, but the addition of
- 14 this acreage created an issue with a depth severance.
- 15 So the result of that was that Spur has filed two
- 16 applications for compulsory pooling in this case, and then
- 17 Case 22760 which you may recall was presented last month by
- 18 my colleague Adam Rankin.
- 19 In that case, 22760, Spur is seeking to revoke
- 20 that existing Division order, and then seeking to create a
- 21 480 acre spacing unit, and then pooling the uncommitted
- 22 interest from the top of the Yeso to a depth of 3150 feet,
- 23 and that's what we were referring to as the shallow unit.
- 24 And so in this case we are seeking to commit --
- 25 seeking to pool the uncommitted interest in that same 480

- 1 spacing unit -- 3150 feet to the bottom of the Yeso.
- 2 So with that I will turn to the packet we
- 3 submitted earlier. You should have it before you, and you
- 4 will have see that Exhibit A is the compulsory pooling
- 5 application checklist, the application is Exhibit B to the
- 6 packet.
- 7 And then Exhibit C is a declaration from the
- 8 landman, Mr. Rett Dalton. And you will see his testimony
- 9 with this case, they are seeking to pool all uncommitted
- 10 interest in the Yeso formation from below 3150 feet to the
- 11 base of the Yeso underlying a standard 480 acre horizontal
- 12 spacing unit, comprised of the SE/4 of Section 6 and the E/2
- of Section 7, Township 19 South, Range 25 East, Eddy County,
- 14 New Mexico.
- 15 And then attached to his statement as C-1 are the
- 16 C-102s for the two proposed Trudy Fed Com Wells, 19H well
- 17 and 91H well, and you will see that the 90H well is a
- 18 proximity tract.
- 19 And then Exhibit C-2 is the land plat and
- 20 ownership interest which shows the ownership interest by
- 21 tract and by unit, and then it's the entity then person
- 22 highlighted in yellow who we are seeking to pool in this
- 23 case. And then C-3 is the well proposal letters and the
- 24 AFEs, and then finally C-4 is the chronology of contacts
- 25 with the working interest owners.

And then Exhibit D is the affidavit from the

- 2 geologist, C.J. Lipinski, and targeting the Yeso formation.
- 3 And then attached to that affidavit are -- is a -- D-1 is a
- 4 locator map, and D-2 a structure map, and D-3 the cross
- 5 sections. And if you take a look at that, you will see that
- 6 the depth severance is illustrated on that Exhibit D-3, and
- 7 you will see the target formation -- the target interval
- 8 for this case and the different wells there, as well as a
- 9 comparison with the companion case that we are seeking to
- 10 pool the interest of the shallow unit. And then Exhibit D-4
- 11 is a gun -- a Trudy gun barrel exhibit.
- 12 And then finally we come to Exhibit E which is
- 13 the affidavit from my colleague Adam Rankin testifying that
- 14 notice of the hearing was provided by our office to the
- 15 names of the affected parties that appear on that
- 16 spreadsheet and then the status of those letters as provided
- 17 to us by the US Postal Service.
- 18 And he also testifies that notice -- not all
- 19 parties were locatable. And then he testified that notice
- 20 of the hearing was provided by publication, and Exhibit F is
- 21 the affidavit of publication by the Carlsbad Current Argus.
- 22 And I stand for any questions.
- 23 HEARING EXAMINER BRANCARD: Thank you. Mr.
- 24 McClure, questions?
- 25 TECHNICAL EXAMINER McCLURE: No, Mr. Brancard, I

- 1 don't have any questions for this case.
- 2 HEARING EXAMINER BRANCARD: I don't have any,
- 3 either, so Ms. Broggi --
- 4 HEARING EXAMINER BRANCARD: So we ran Mr. Rankin
- 5 through the ringer on the first go-round.
- 6 MS. BROGGI: Better him than me.
- 7 HEARING EXAMINER BRANCARD: You are just here to
- 8 do clean-up.
- 9 MS. BROGGI: So with that, we would move the
- 10 admission of A through F, and we would ask that the Division
- 11 take the case under advisement.
- 12 HEARING EXAMINER BRANCARD: Thank you. Are there
- any other interested persons for case 22920?
- 14 (No audible response.)
- 15 HEARING EXAMINER BRANCARD: Hearing none, the
- 16 exhibits will be admitted into the record and Case 22920
- 17 will be taken under advisement. Thank you.
- MS. BROGGI: Thank you very much.
- 19 (Exhibits admitted.)
