


HEARING EXAMINER BRANCARD: Okay. Thank you. So I think we are now on 22, case 22925 and In-vee-to or In-vi-to Operating.

MS. HARDY: May it please the Examiner, Dana Hardy with Hinkle Shanor on behalf of Invito Operating LLC.

HEARING EXAMINER BRANCARD: And we have an entry of appearance, Tierra Oil Company.

MR. RICHARDSON: Mr. Examiner, this is Jack Richardson with J Bar Cane Royalty, and I know Tierra is on the call, they may be having some technical difficulties at this time.

HEARING EXAMINER BRANCARD: All right. Ms. Hardy, I think you asked for a status conference.

MS. HARDY: Yes, Mr. Examiner. It's my
understanding that Tierra filed an objection to the case being heard by affidavit. I think there are issues with that objection. I think it was filed by Mr. Barnhill representative of Tierra Oil, and I don't think a non-attorney can represent entities or other parties in the Division proceedings under New Mexico law and under the Division's rules. I think that's an issue that will have to be addressed, but at this point think we would ask that the case be set for a contested hearing on the first October docket.

I was having technical difficulties, but I don't believe $I$ have anything further to add at this point, just that we are representing about 20 percent of mineral interests under this proposed well, and we are unleased and just seeking fair terms for a lease.

HEARING EXAMINER BRANCARD: Thank you, okay. So we will set -- is there any objection, Mr. Barnhill, to the October 6 setting?

MR. BARNHILL: No, sir.

HEARING EXAMINER BRANCARD: Thank you. So case 22925 will be set for a contested hearing on October 6. I will issue a prehearing order.
