2	cases 22723, 22724, 22725, 22726, Mewbourne Oil
3	Company.
4	MR. BRUCE: Mr. Examiner, Jim Bruce,
5	representing Mewbourne Oil Company.
6	HEARING OFFICER BRANCARD: Are there any
7	other entries of appearance for cases 22723, 724, 725,
8	726?
9	Hearing none, Mr. Bruce, you may proceed.
LO	MR. BRUCE: Mr. Examiner, again, similarly in
L1	these cases, Mewbourne seeks to amend the original
L2	pooling orders, request an additional year in which to
L3	commence the wells that are the subject of these cases,
L 4	Local Legend 18/17, second Bone Spring wells which
L5	collectively cover all of Sections 18 and 17, Township
L6	18 South, Range 31 East.
L7	Each exhibit, the exhibit package contains
L8	the applications and notices, copies of the original
L9	pooling orders which were issued a little more than a
20	year ago, July 15, 2021. They contain a landman's
21	affidavit somewhere along the way here, and let me find
22	it.
23	The reason for the request is the same as in
24	the prior Matador cases, which is that the BLM has not
) 5	wet issued ADDs for these wells after a wear

1	I'm sorry, I too much paper. I'm trying
2	to find the landman's affidavit.
3	HEARING OFFICER BRANCARD: Mr. Bruce, I have
4	it as Page 14 of your exhibit packet.
5	MR. BRUCE: Oh, okay. Okay. I'm not too
6	alert here.
7	But anyway, that is the basic reason ah,
8	here it is, yes. Thank you, sir.
9	Again, the sole reason for the extension
10	request is the BLM's need to approve the APD's which
11	have been pending for close to a year. And Mewbourne
12	does still intend on drilling the wells.
13	And I also submitted additional materials, a
14	green card from Apache Corporation which pertains to
15	case 22723 only, and then another exhibit, a green card
16	from OXY USA which pertains to case 22725, and the
17	supplemental exhibits also contain a spreadsheet.
18	Everyone and it's in the exhibit
19	packages did receive certified mail. The only issue
20	is this. I checked the US Postal Service website
21	several times which shows that J. Hiram Moore Limited
22	did receive the certified mail on June 4th. I have yet
23	to receive a green card back from them.
24	I would assert that notice is complete if in
25	the original pooling cases which were heard a year ago,

1	this notice was mailed to J. Hiram Moore at the same
2	address used for this notice letter, and a green card
3	was returned. And I also personally checked online to
4	find the address of J. Hiram Moore and it is the
5	address given in my notice affidavit.
6	And so even though I don't have a green card,
7	I would submit that notice is complete and everyone has
8	received notice of these applications. And if the
9	Division wants me to do something further, the J. Hiram
10	Moore notice only involved case 22726.
11	With that, I move the admission of Exhibits 1
12	through 3 and Exhibits A, B and C, the supplemental
13	exhibits.
14	HEARING OFFICER BRANCARD: Thank you.
15	Mr. Lowe, any questions?
16	TECHNICAL EXAMINER LOWE: I have no
17	questions. Thank you.
18	HEARING OFFICER BRANCARD: Mr. Bruce, I don't
19	know if you ever found your land affidavit.
20	MR. BRUCE: I did. I did.
21	HEARING OFFICER BRANCARD: Just to let you
22	know, there's a typo on Paragraph 7. It says you're
23	extending it one year from 2021 to 2023.
24	MR. BRUCE: Ah, I will I will correct that
25	immediately.

1	HEARING OFFICER BRANCARD: That's two years.
2	So you're just waiting for a green card, is
3	that what the issue is here, Mr. Bruce? Or some is
4	there confirmation from the postal service?
5	MR. BRUCE: I did submit, with my notice
6	letter, a copy of what is online at the postal service.
7	It's showing that and actually when this these
8	matters were, when I prepared the exhibit packages, I
9	didn't have green cards back from Apache or OXY USA, so
LO	I included the online notices or tracking information
L1	from the postal service showing that they had received
L2	notice. But, again, I did subsequently receive green
L3	cards from Apache and from OXY USA, Inc.
L 4	But the final, if you look at the final page
L5	of part two of my exhibits, you will see the final page
L6	of all of the exhibits where I sent notice out to J.
L7	Hiram Moore Limited, and it says that it was delivered
L8	June 4, 2022. And six weeks later, I still have not
L9	received a green card back. And, again, that only
20	applies to the last case 726.
21	HEARING OFFICER BRANCARD: Okay.
22	All right. Are there any other interested
23	persons then for cases 22723, 724, 725, 726?
24	Hearing none, these cases will be taken under
25	advisement and the exhibits will be admitted into the
