UNOPPOSED MOTION TO DISMISS WITH PREJUDICE

Rockwood Resources, LLC (“Rockwood”) moves the New Mexico Oil Conservation Division (“Division”) to dismiss Case Nos. 22539 and 22540, above referenced, with prejudice. Counsel for the parties involved have been notified, and no objections have been expressed. In support, Rockwood states as follows:

REASONING

1. Rockwood Resources, LLC (“Rockwood”), Christine Brock (“Brock”), and Rebecca J. Babbitt (“Babbitt”) (collectively referred to as “Rockwood Group”) filed applications in Case Nos. 22539 and 22540, on January 14, 2022 (“Applications”), to reopen Case Nos. 21390 and 21391 previously filed by Mewbourne Oil Company (“Mewbourne Cases”).

2. After an initial hearing on March 3, 2022, to consider the first motion to dismiss filed by Mewbourne Oil Company (“Mewbourne”) and the Rockwood Group’s request for continuance, the Division Hearing Examiner established a schedule for further briefing and motion hearing. The issues were fully briefed by the parties, and the Division made its rulings on the motions.

3. Rockwood and Mewbourne have since resolved their differences, and Rockwood respectfully requests that Case Nos. 22539 and 22540 be dismissed accordingly. Mewbourne concurs with this request.

WHEREFORE, Rockwood respectfully requests that the Division grant its Motion to Dismiss Case Nos. 22539 and 22540.
