The Oil Conservation Commission meeting was a hybrid meeting with both in person and virtual participation options. The meeting was held in Room 317 at the New Mexico State Capitol, 490 Old Santa Fe Trail, Santa Fe, New Mexico.

The hearing was called to order by Chair Fuge at approximately 9:04 a.m.

Item 1. Roll Call.

Action: Roll was taken; a quorum was present.

Item 2. Approval of the Agenda.

Action: Commissioner Bloom made a motion to adopt the June 08, 2023 agenda and Commissioner Ampomah seconded the motion. A roll call vote was taken. The motion carried unanimously.

Item 3. Approval of the May 11, 2023 Meeting Minutes

Action: Commissioner Bloom made a motion to approve the May 11, 2023 minutes and Commissioner Ampomah seconded the motion. A roll call vote was taken. The motion carried unanimously.

Item 4. Adjustments to August and September Meeting Dates

Action: The Commission discussed changing the August and September Commission meeting dates because of conflicts with the Commissioners' schedules. The Commission agreed to move the August hearing date from the 10th to August 17, 2023 and to move the September hearing date from the 14th to September 7, 2023. Chair Fuge announced that the new hearing dates will be posted on the OCC website.

Item 5. Pending cases

Action: Daniel Rubin introduced himself as the new Commission attorney. He announced that there were no pending cases. They were all continued to the August and September hearings.

Item 6. Pending litigation

Action: Mr. Rubin discussed the Atencio case and the extension of the deadline to answer. He said the Commission will have some closed sessions to discuss the litigation.
In the Marker vs. OCC case, the district court's order was affirmed and adopted.

Item 7. Other business


