Subject: RE: BW-27 and BW-30 Pyote Well Services, LLC WQCC Discharge Permits Transfer of Discharge Permit to Cambrian Management

Ms. Usher:

Good afternoon. The New Mexico Oil Conservation Division (OCD) is in receipt of your e-mail message below. More specifically, Jim Griswold (OCD) forwarded your e-mail message to me, and after conferring on the OCD Water Quality Control Commission (WQCC) Regulations for Brine Well Discharge Permits, i.e., BW-27 and BW-30, it appears that Pyote and Cambrian must abide by WQCC Regulation: 20.6.2.5101(H) NMAC provided below.

WQCC Regulations: [20.6.2 NMAC](#)

20.6.2.5101 DISCHARGE PERMIT AND OTHER REQUIREMENTS FOR CLASS I WELLS AND CLASS III WELLS:

H. Transfer of Class I non-hazardous waste injection well and Class III well discharge permits. (1) The transfer provisions of 20.6.2.3111 NMAC do not apply to a discharge permit for a Class I non-hazardous waste injection well or Class III well. (2) A Class I non-hazardous waste injection well or Class III well discharge permit may be transferred if: (a) the secretary receives written notice 30 days prior to the transfer date; and (b) the secretary does not object prior to the proposed transfer date; the secretary may require modification of the discharge permit as a condition of transfer, and may require demonstration of adequate financial responsibility. (3) The written notice required by Subparagraph (a) of Paragraph (2) of Subsection H above shall: (a) have been signed by the discharger and the succeeding discharger, including an acknowledgement that the succeeding discharger shall be responsible for compliance with the discharge permit upon taking possession of the facility; and (b) set a specific date for transfer of discharge permit responsibility, coverage and liability; and (c) include information relating to the succeeding discharger's financial responsibility required by Paragraph (17) of Subsection B of 20.6.2.5210 NMAC.

No transfer of ownership is possible without proper financial assurance. It is imperative that Cambrian Management submit WQCC financial assurance (i.e., [WQCC-1 Bond](#), or [other acceptable means](#), etc.) to the Mrs. Denise Gallegos (OCD Bond Administrator) at (505) 476-3453 in amount acceptable to the OCD Environmental Bureau. A third-party cost estimate for plug and abandonment of the brine well, restoration of the surface to prior conditions, subsidence and any environmental monitoring if required shall be factored into the cost estimate for OCD Environmental Bureau approval. Once the amount is approved, Cambrian Management may submit the financial assurance to Ms. Gallegos approval. Once approved, Pyote may request a release of its bond(s).

OCD has examples of transfer documents should they be requested by the parties. The examples strive to satisfy 20.6.2.5101(H) above to properly transfer the discharge permit and well to the new owner. Essentially, the new owner must confirm it understands the terms and conditions of the discharge permits and accepts full responsibility henceforth.
