Please see the response below that I received from Basic Energy Services with regard to the leak.


Update on the Eunice leak:

1. The picture is of the loading pad and loading line, in the picture you can see the wafer valve open, behind that wafer valve is an electronic actuator valve. We have made an adjustment to that valve which in turn repaired the leak.
2. We are taking bids to construct a concrete offload pad that will stop future spills coming from the load line.
3. All tanks have been emptied until we have renewed our permit.

Mr. Chavez:

Basic Energy has completed the cleanup of the brine release from the well leak. The affected area was scraped and excavated, with the contaminated soil being hauled to Sundance Disposal. Two samples were taken, one eight feet East of well head and sample 2, thirty feet East of well, photos are attached. Also Basic has put a berm up around well to prevent future accidents.

Basic has its budget approved to completely recondition this facility. Our plan it to replace old tanks, rebuild pump area, new berming and put plastic liner under tanks and pad. We will keep you and the Hobbs OCD informed of the construction.
