Here is the final inspection and information regarding the clean-up efforts performed at the above mentioned lined facility. All of the free fluids were removed and if present the impacted gravel was removed from the liner and taken to a NMOCD approved disposal facility. The liner was inspected for damage and found the liner integrity to be intact. In addition, there was some overspray (approximately 20' x 20') on the pad located on the edge of the facility. One (1) sample was collected in the over spray area and showed concentration below the Table 1 (<50 feet Closure Criteria), with BTEX concentrations above the laboratory limit, TPH of 27.3 mg/kg and a chloride of 38.3 mg/kg. Based on the liner integrity and results, the Final C-141 and pictures taken during the final inspection conducted by a COG HSE representative are attach for your review.
