Yesterday afternoon on 4/22/2019 Apache Corporation discovered a release due to heater treater gasket failed resulting in the loss of 25 barrels of water and 10 barrels of oil with 8 barrels of oil recovered and 4 barrels of water recovered. The battery is located in unit letter L section 27 township 21S range 37E. GPS Coordinates of source are 32.44928 -103.15499. A vacuum truck was dispatched to pick up standing fluid in the pad. All the standing fluid was contained on the lease pad except for some light overspray that affected the pasture to the south. Please let me know if you have any questions or wish to discuss.
