Mr. Fergerson,

The NMOCD has received the Extension Request for Soil Remediation and Site Restoration at the Solaris-Okeanos SWD #1 Flowback Line (1RP-5407). The OCD is unable to grant an extension of time for soil remediation and site restoration activities at this time. Terracon submitted the site characterization and remedial action plan within 90 days of discovery of the release, and is therefore in compliance with 19.15.29.11 NMAC. No further action is required on Terracons part until the plan is reviewed and accepted. Once the plan is accepted, then closure activities need to take place within 90 days from acceptance. However, if the OCD has not reviewed the plan by June 25, 2019 (60 days after submission), please resubmit the remediation plan, as it will have been deemed administratively denied at that point.

The other option would be to proceed with closure activities and closure reporting without a previously accepted remediation plan. This route could prove more expedient, but runs the risk of requiring additional work if the OCD does not approve the closure activities.
