The NMOCD has reviewed the fifth annual groundwater monitoring reports detailing the monitoring and remediation activities conducted at both the CHK State M and L Leases (AP-72, AP-73). The findings in the reports indicate that activities are progressing in accordance with the approved Stage 2 Abatement Plans. The NMOCD does not see any reason to depart from the current activities at this time.

However, after a file review it was determined that the NMOCD does not currently possess the first, third, or fourth annual reports for either AP-72, and AP-73. This is credited to the turnover within the Division and changes in the online reporting system, and not to Equus's lack of submission.
