The OCD has received the form C-141 you provided on \_5/14/2019\_ regarding an unauthorized release. The information contained on that form has been entered into our incident database and remediation case number \_1RP-5529\_ has been assigned. Please refer to this case number in all future correspondence. However, because the nature of the release, there is no corrective action possible and the case has also been administratively closed.

Note: 19.15.29.10 A. (1) NMAC requires that the responsible party notify the Division Bureau Chief and the appropriate division district office within 24 hrs of discovery of a major release. Additionally, under 19.15.29.10 A. (2) initial C-141 filing forms are due 15 days after discovery of the release. Neither of those stipulations were adhered to in this case, and 19.15.29.15 NMAC also states the responsible party must comply with all the requirements of 19.15.29 NMAC. The division may take enforcement action against any responsible party who does not comply with 19.15.29 NMAC pursuant to 19.15.5.10 NMAC.
