Mr. Baker,

The remediation plan submitted for NMOCD District 1 Remediation Permit (1RP) 5252 is denied. The Division does not consider the contamination represented by composite point 5 and 6 to be fully delineated. The sample results at 6 inches depth and 1 foot depth are greater than the remediation levels in Table one of 19.15.29.12 NMAC. Therefore, excavating the area to 1 ft in the area is not sufficient. The division requests that depth at which Table 1 contaminant concentrations are lower than minimum regulatory values is found.

On the other hand, the division does not object to the sampling taking place at the same time as excavations, it only requests that excavation proceed until the vertical and horizontal delineation is achieved.

Note: The division would prefer that point samples at specific depths be taken as opposed to composite samples.
