Mr. Taylor,

The NMOCD has reviewed the proposed workplan for the Carlson Fed A 2 TB site (1RP-5525). To accept the remediation plan, the OCD would like to see more information regarding:

- Stockpile remediation.
 - The OCD has no problems with in situ remediation, but the Division requires more information on the proposed process. For instance:
 - Will the stockpiles be bermed and lined?
 - How will the piles be laid out?
 - How will excess water be managed?
 - How will treatment be applied?
 - List of major ingredients in "BioWash" and "AMS 101"
 - The OCD would like to see more than a four spot composite sample on the remediation piles and a description of the where within the piles samples will be taken (i.e. middle of pile, edge, top).
- Additionally, based on review of provided soil data, the OCD recommends that the entire area of concern be
 excavated to two feet below ground surface before taking confirmatory bottom hole samples to determine if all
 constituents of concern have been removed.
