Under the new spill rule a closure report is due for the above release on July 28, 2019. COG would like to request an three month extension until October 28, 2019. This is a newly drilled well and we could not get on location to conduct delineation activities. We recently conducted an inspection of the location to determine if we could conduct delineation

activities. Upon inspection there are two portable flares on location in an area near the area needing to be delineated. COG does not think conditions are safe for delineation activities at this time due to the flaring occurring on location. We will make periodic inspections of this site and when conditions are deemed safe we will conduct delineation activities.

Please find the attached C-141 for your consideration. Also, attached is the calculation sheet to determine the estimated release volume. The liquid lost estimate is based on the spill dimensions, estimated depth of fluid (wet soil depth) and type of formation. The spreadsheet will calculate the volume lost in the ground and does not include the recovered amount in the calculation.
