Mr. Billings,

Cardno, on behalf of ExxonMobil, will be performing the 2<sup>nd</sup> half 2020 groundwater monitoring event at the subject site on Dec 15<sup>th</sup> – 17<sup>th</sup>.

During the monitoring program, sulfate has only been measured above the NWMQCC regulatory limit of 600 mg/L in one well (MW20), and in MW20, the concentration has declined and remained below the limit for nearly 8 years (since July 2012), therefore approval is requested to remove sulfate from the groundwater monitoring analytical program.
