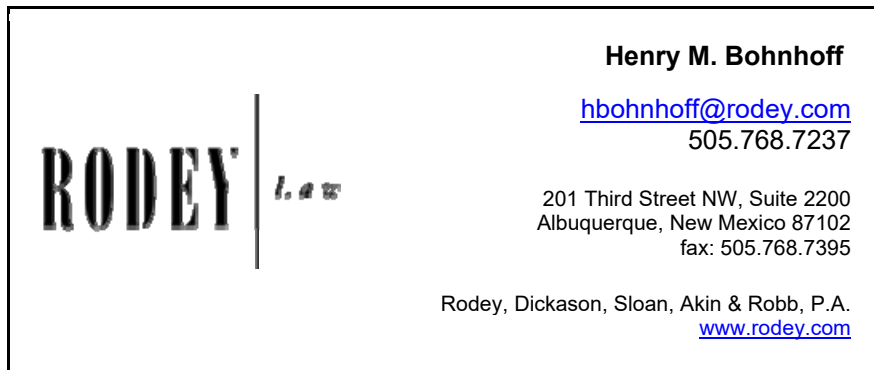

(collectively, Sundance") to construct and operate a new surface waste management facility to be located on or near Section 30, T.21S., R.38E., N.M.P.M., Lea County, New Mexico, and/or move/modify/close an existing surface waste management facility located on or near Section 29, T.21S., R.38E., N.M.P.M., Lea County, New Mexico ("Applications"), including but not limited to:

1. The Applications;
2. All OCD and OCC internal analyses and/or evaluations, including drafts, and other communications, regarding the Applications;
3. All reports and communications to or from other state agencies, including the Oil Conservation Commission, regarding the Applications, and documents reflecting OCD/OCC consideration of such communications;

4. All reports and communications to or from contractors retained by the OCD to review, analyze and evaluate the Application, and documents reflecting OCD/OCC consideration of such communications;
5. All communications to or from Sundance regarding the Applications, and documents reflecting OCD/OCC consideration of such communications; and
6. All communications to or from third parties regarding the Applications, and documents reflecting OCD/OCC consideration of same.
