The New Mexico Oil Conservation Division (OCD) inspected DD Landfarm, Inc (DD) on August 12, 2003. The OCD found the facility to be well maintained and have good security (see photo 1). Tilling and inspection records were reviewed. All tilling and inspections have been performed according to permit requirements (see photos 2 and 3). A review of the financial assurance portion of Permit NM-01-0034 finds that a cash bond and assignment in the amount of \$83,479 is on file. However, according to the Permit, DD is required to submit additional financial assurance by December 18, 2003 to increase the amount to **\$111,329**. 


Photo 1: Entrance with locking gate and sign with name, permit number, legal location, and emergency phone numbers. Looking North.


