The Oil Conservation Division (OCD) has received your request, dated November 20, 1994, for authorization to discharge approximately 8,820 gallons of waste water from the hydrostatic testing of a section of used pipeline (30" mainline) at Transwestern Pipeline Company's Belen River Crossing located near Belen, New Mexico.

Based on the information provided in your request, the hydrostatic test water discharge is hereby approved subject to the following conditions:

1. The test waters will not be discharged to waters of the State of New Mexico.
2. Any solids that accumulate must receive separate authorization from the OCD prior to disposal and the request must be accompanied with laboratory analysis to characterize the solids.

Pursuant to WQCC Regulation 3-106.B, this approval will allow you to discharge without an approved discharge plan for a period not to exceed 120 days. If the site is to be used for more than one test discharge, formal reapplication must be made. If the discharge exceeds 120 days, a formal discharge plan must be submitted for review.

Based on the information provided in your request, the hydrostatic test water discharge is hereby approved subject to the following conditions:

1. The test water will be contained in the pipe to be tested until the analytical results from a full characterization determines if the waste exhibits hazardous characteristics
2. The analytical results will be made available to the OCD along with your request to dispose of the test water.
3. Any solids that accumulate as a result of the discharge will be subject to full characterization testing to determine proper means of disposal.
4. The analytical results will be made available to the OCD along with your request for disposal of the accumulated solids.



The Oil Conservation Division (OCD) has received your request, dated September 6, 1994, for authorization to discharge approximately 85,000 gallons of waste water from the hydrostatic testing of a section of new pipeline (30" mainline) located at Transwestern Pipeline Company's Rio Grande River Crossing Expansion.

Based on the information provided in your request, the hydrostatic test water discharge is hereby approved subject to the following conditions:

1. Permission will be obtained from the landowner prior to discharge.
2. The test water will be discharged onto the ground after first passing thru hay bales to prevent erosion.
3. The pipe must be new and never used for oil and/or gas transmission.
4. Fresh water will be used to conduct the test.

Pursuant to WQCC Regulation 3-106.B, this approval will allow you to discharge without an approved discharge plan for a period not to exceed 120 days. If the site is to be used for more than one test discharge, formal reapplication must be made. If the discharge exceeds 120 days, a formal discharge plan must be submitted for review.

4. The analytical results will be made available to the OCD along with your request for disposal of the accumulated solids.


