Mr. Martin,

This memo is to notify the New Mexico Oil Conservation Division of planned hydrotesting of Segment 2 of the SFPP East Line Expansion Project. The attached map indicates the location of this segment of pipeline. This will be new pipe that has not yet contained petroleum product. Please provide written approval to the address above.

The 161.1 mile segment is going to be hydrotested in six sections; however, only the first five sections are located in New Mexico. The five New Mexico sections are listed below with information such as location, volume of water, and water source. Dewatering of the test sections will most likely take place on October 18 and November 30, 2005.

Test Section # 1

1. MP 46.7 to MP 80.1 (Afton to Akela BV)
2. Township 24S, Range 5 W, Section 6 in Luna County, NM
3. Water source: Deming City Water
4. Volume of water : 39,700 bbls

Test Section # 2

1. MP 80.1 to MP 103.6 (Akela BV to Deming Station)
2. Township 23S, Range 9W, Section 29 in Luna County, NM
3. Water source: Deming City Water
4. Volume of water : 34,000 bbls

Test Section # 3


1. MP 103.6 to MP 131.5 (Deming Station to MP 131.5)
2. Township 24S, Range 13W, Section 19 in Luna County, NM
3. Water source: Deming City Water
4. Volume of water : 31,300 bbls

Test Section # 4

1. MP 131.5 to MP 156.7 (MP 131.5 to Lordsburg Maintenance Station)
2. Township 23S, Range 17W, Section 8 in Hidalgo County, NM
3. Water source: Private Well on Rex Kipp's property
4. Volume of water : 30,400 bbls

Test Section # 5

1. MP 156.7 to MP 178.5 (Lordsburg Maintenance Station to Steins Pass)
2. Township 24S, Range 20W, Section 7 in Hidalgo County, NM
3. Water source: Private Well on Rex Kipp's property
4. Volume of water : 33,400 bbls




VICINITY MAP
