

Dear Wayne:

Per your request during our meeting on Wednesday, March 14, 2001, this letter will outline the agreement for the surface remediation of the property owned by Gary Schubert in Hobbs, New Mexico by Chevron USA.

Chevron USA has agreed with Mr. Schubert that the top 6" to 8" of the soil in Area 1 (old pit site) will be removed and replaced with clean soils provided by Mr. Schubert. The "Schubert Site Investigation" dated March 9, 2001 revealed a Total Petroleum Hydrocarbon (TPH) level in the sample from bore hole # 5 at 0'-2' in Area 1 to be 9,440 ppm. Chevron USA has agreed to excavate that area and remove all soils over 5000 ppm TPH. All other samples had TPH levels under 5000 ppm. The surface in Area 2 (battery site) will be left in place with the exception of an area approximately 50' X 50' on the east side of the site. The top 6" to 8" of soil in that area will be removed and replaced with clean soil provided by Mr. Schubert.

This plan of action is agreeable with the landowner, Mr. Schubert, and will adequately maintain the surface for future use.
