The New Mexico Oil Conservation Division has received your "Site Closure Documentation (for the) Plains All American Pipeline Mescalero Ridge #2001-10917" site located in Unit Letter I, Section 17, Township 19 South, Range 35 East, Lea County, New Mexico (NMOCD reference 1R-0409).

Closure of this site is hereby approved with the following condition:

Re-vegetation of the site should commence as soon as possible. Since it is somewhat late in the growing season, a second application of seed may be needed in the Spring of 2005.
