General Description of Remedial Action: Chlorides and TPH field tests were

conducted consistently as the site was excavated to 30 x 25 x 16 ft deep. Although

TPH concentrations were well below NMOCD guidelines, chloride impact did not exhibit a

decline with depth. The excavation was backfilled to 3 ft bgs with the excavated soil that was

remediated on site. At 3 ft, a 20 mil poly liner was installed in a convex manner as illustrated in

the attached diagram. From 3 ft up to the surface was backfilled with imported clean soil and

contoured on top of the liner. The surface will be re-seeded with native vegetation and will be

monitored for growth. A new watertight junction box has been built 30 ft southwest of this

location.


CHLORIDE CONCENTRATION CURVE






