The New Mexico Oil Conservation Division (NMOCD) is in receipt of Rice Operating Company's (ROC) letter dated July 14, 2005 submitted by Arcadis G&M, Inc. on behalf of ROC. The letter requests that OCD rescind its request for ROC to submit an abatement plan pursuant to Rule 19. OCD has reviewed the file with the following facts stated:

1. ROC reported groundwater impact on April 07, 2003.
2. The major source of contamination was removed and remediated.
3. A barrier was installed to prevent infiltration.
4. A monitor well was installed to verify groundwater conditions. Generally when groundwater exceeds standards, OCD normally requires delineation of the groundwater. However, after reviewing the file it appears the initial sampling and testing provided a false positive. The groundwater is currently below water quality standards and has statistically remained below.

After careful review of this project, OCD hereby approves of your request with the following conditions:

1. Please provide documentation showing how ROC plans to implement institutional and/or engineering controls to protect the liner in the foreseeable future.

2. Please provide documentation showing that the monitor well has been properly plugged and abandoned.
