Dear Ms Pope and Mr. Van Deventer:

OCD is in receipt of the ICP for the above subject site. Since this site has confirmed groundwater impact and over one year has transpired, OCD will require ROC to submit an abatement plan pursuant to OCD rule 19. In order to expedite this process OCD recommends that you submit a combined stage 1 and stage 2. Please submit this plan by no later than November 30, 2006.

This plan has been assigned OCD case # AP-58. All correspondence shall have this number included.
