Dear Bill:

Pursuant to our conversation in Hobbs yesterday, at which time I requested that our application for formal hearing in Case No. 762 be dismissed, I am enclosing waivers executed by Cities Service Oil Company, Gulf Oil Corporation, and John Kelly, being all of the operators owning interests outside of the section and within 1500 feet of our State Unit E-1 Well. To the best of my knowledge, all of the parties owning interest in the N $\frac{1}{2}$ of the unit will be involved in the pooling agreement covering the S $\frac{1}{2}$ of Section 35.

It will be appreciated if you will issue an order in accordance with Rule 5(b) of Commission Order R-520 approving the non-standard gas proration unit and unorthodox well location as soon as possible, and in any event in time to permit the assignment of a full 320-acre allowable to this well for the month of November. 
Gentlemen:






