Gentlemen:

El Paso Natural Gas Company requests your approval to form a Non-Standard Gas Proration Unit of 160 acres more or less consisting of the NE/4 of Section 36, Township 20 South, Range 36 East, N.M.P.M., Lea County, New Mexico. El Paso Natural Gas Company's Shell State #10 Well is located on this tract. Said well is located 1980 feet from the north line and 990 feet from the east line of Section 36.

El Paso Natural Gas Company makes the following allegations, to-wit:

1. That the Non-Standard Gas Proration Unit consists of a contiguous quarter section.
2. That the Non-Standard Gas Proration Unit lies wholly within a single governmental section.
3. The entire Non-Standard Gas Proration Unit may reasonably be presumed to be productive of gas.

4. The length or width of the Non-Standard Gas Proration Unit does not exceed 5280 feet.


