Mr. Littrell,

OCD has received your Deferral request and C-141 for PLU Big Sinks 14-25-30 Battery (30-015-39508 Poker Lake CVX JV BS 8H) release 9-11-19 **2RP-5663**, thank you. This deferral request is DENIED because this site does not meet the criteria to apply for a deferral.

- Rule NMAC 19.15.29.12.C.2: If contamination is located in areas immediately under or around production equipment such as production tanks, wellheads and pipelines where remediation could cause a major facility deconstruction, the remediation, restoration and reclamation may be deferred with division written approval until the equipment is removed during other operations, or when the well or facility is plugged or abandoned, whichever comes first. **The DEFERRAL may be granted so long as the contamination is fully delineated** and does not cause an imminent risk to human health, the environment or ground water.

OCD understands that due to pipeline and equipment infrastructure in the containment area, limitations on excavation activities exist. However, the OCD strongly recommends that XTO attempt to delineate the soil underneath the breached liner using a manual auger before repairing the liner.
