We had two drain valves freeze and break on two horizontal separators. We recovered all standing fluid out of the lined containment, replaced the valves and we will power wash the containment.

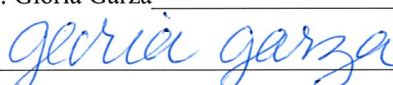
