XTO is requesting an extension of the current deadline of July 8, 2019 at the PLU 18 Brushy Draw 104H (2RP-5395). The release was discovered April 9, 2019. During frac operations produced water was released to the well pad. XTO was able to begin initial site assessment May 6, 2019 but frac and flowback operations are still ongoing preventing further remediation work at the site. To ensure safety of all personnel, no non-essential staff are allowed on site until frac and flowback operations are complete. XTO is requesting an extension of the deadline until October 8, 2019.
