Cause of Release: On October 25, 2020, Enterprise had a release of produced water and lubrication oil at the Cedar Hill Compressor Station. The release was a result of the Emergency Shutdown (ESD) event. The released fluids were ejected from the facility ESD vent. Enterprise determined the release reportable on November 4, 2020 after receipt of laboratory analysis indicating an area of approximately 80 feet long by 40 feet wide was impacted by the released fluids. All fluids remained on the facility property. No washes/waterways were affected. Remediation activities are in the scheduling process. A third party corrective action report will be submitted with the "Final C-141."
