**Subject:** [EXT] XTO - Extension Request Nash #53 SWD (NRM2022758966) and additional releases

All,

XTO is requesting an extension to the 90-day deadline for submitting a remediation work plan or closure report required in 19.15.29.12.B.(1) NMAC at the Nash Unit #53 SWD/Nash 4 for four recent releases. The releases occurred between August 3, 2020 and January 23, 2021. XTO is attempting to address the four releases concurrently. A description of the releases follows:

- Incident number NRM2022758966 was discovered August 3, 2020, and an initial site assessment was conducted. XTO has conducted remediation work for this release. To date, approximately 1,500 cubic yards of impacted soil have been removed. XTO submitted a Right of Entry (ROE) Permit to the State Land Office (SLO) on October 27, 2020 to request access to the pasture in order to complete delineation and the permit was approved and received by XTO on December 10, 2020. An extension for this release was previously granted by NMOCD with a current due date of February 1, 2021.
- Two releases were discovered on January 2, 2021 and one release on January 23, 2021. These releases overlap the excavation associated with NRM2022758966. Incident numbers have not yet been assigned to the new releases.

To provide enough time for all releases to be addressed concurrently, additional delineation activities are necessary following the new releases before completion of a final remediation work plan or closure report. XTO requests an extension for submittal of the work plan or closure report for the aforementioned releases until May 2, 2021.
