
Cause of Release: On December 24, 2020, Enterprise had a release of natural gas and natural gas liquids from the Blanco C-51 pipeline riser. An area of approximately 20 feet in diameter was impacted by the released fluids. No washes/waterways were affected. The pipeline was isolated, depressurized, locked and tagged out. Remediation of the release is in the scheduling process. A third party corrective action report will be submitted with the "Final C-141."
