 job to 1305 preparatory to acidizing pay section
 between 1260-1300. Used 250 gal hydrochloric
 acid with 500" pressure, swabbed out and run
 in 1000 gal hydrochloric acid with 1500" pressure
 which blew by plug. Run Hydromat to 1395 but
 did not hold. Closed operations to drill offset to determine
 what to do with this well.
