On 4-11-81 Salizar Brothers (Rig #13) spudded a 12-1/4" hole at 6:30 p.m. Drilled to a TD of 713' and ran 8-5/8" casing set at 713'. Cemented with 500 SX Class H cement. Plugged down 12:35 a.m. 4-13-81. Circulated 200 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2308' and ran 5-1/2" casing set at 2308'. Cemented with 750 SX Class H cement. Plugged down 8:30 p.m. 4-17-81. Circulated 210 SX. Currently waiting on completion unit.
