Reamed to 1350'

Cemented 1339' 24# J-55 8 5/8" casing @ 1350' w/ 150 sacks of regular neat cement with 3% calcium chloride added. (Guide shoe) Cement was allowed to set 24 hours, casing was tested with 500 pounds water pressure 30 minutes; held O.K. Schlumberger temperature survey indicated top of the cement behind 8 5/8" casing was at 1200'.

July 12, 1959 Squeezed from top 250 sacks regular neat cement with 3% calcium Chloride added; cement was allowed to set 24 hours.

The purpose of running this intermediate string was to shut of shallow surface water (see sketch attached).
