On 4-13-81 CO2 in Action (Rig #19) spudded a 12-1/4" hole at 5:00 p.m. Drilled to a TD of 709' and ran 8-5/8" casing set at 709'. Cemented with 500 SX Class H cement. Plugged down 12:30 p.m. 4-14-81. Circulated 200 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2635' and ran 5-1/2" casing set at 2635'. Cemented with 800 SX Class H cement. Plugged down 4:30 p.m. 4-18-81. Circulated 250 SX. Currently waiting on completion unit.
