Attached is the final sampling map for the site and the corresponding lab. The site was excavated in two parts. The east side of the release was excavated to a depth of 4 ft bgs, and final wall and a bottom grab sample were taken to a commercial laboratory for analysis. The west side of the release was scraped down 6 inches. A bottom sample from the 6 inch scrape was also taken to a commercial laboratory for analysis. Based on the laboratory results from the final sampling, Apache respectfully requests permission to backfill the site with clean soil. If you have any questions, please contact Bruce with Apache.
