Your remediation proposal is approved for a 1' removal of material across the area identified as S-1 through S-5 (on the well pad). In the areas identified as S-6, S-9 and S-10, you are approved for a 3' removal of material. In the area identified as S-7, further delineation and deeper excavation, based on the results of the delineation, will be required. There is not an area identified as S-8 on the proposal. Confirmation sidewall samples will be required in the off pad area.

This is a written notification to follow up our verbal communications earlier today for SRO State Com #5H (30-015-37425) operated by COG Operating LLC. During a routine pump change, which required pulling the rods and pump it became necessary to pull tubing. At approximately 2:30pm on 7/1/14, while pulling tubing, the well kicked, and the BOP rams were unable to close around the tubing. We currently have a third party well service company on site to address the problem. The location has been secured by blocking the lease road for ¼ mile in both directions.
