Your remediation plan is approved with the following exceptions:

- Due to conflicting depth to ground water data, and the possibility that there may be shallower ground water in this area, OCD requests a liner be used.
- If 2RP-1859 (DOR:8/17/2013) occurred in the same location please ensure you include it in the closure report.

OCD approval does not relieve the operator of liability should their operations fail to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
