Lupe,

The BLM requests the following adjustments to your work plan, S1 and S2 need to be excavated to a minimum of 4' (four feet). S3 is accepted as written with the continued delineation.

While you have equipment on site...why don't you use the material from the "stinger" on the BKU 530 as backfill? That should have been removed during Interim Reclamation. Test the caliche to make sure it is clean prior to use. If you do not choose to utilize it, then it will need to be removed at the end of this clean-up and the area reseeded along with the rest.
