Mike,

I have attached the site map, laboratory results, and final C-141 for the Willow Lake SWD #1. The release left Pyote's location and entered the pasture on private land. The surface owner's company preformed the dirt work associated with this remediation. Pyote contracted Talon to collect confirmation soil samples from the excavation. Upon receipt of analytical results from the confirmation sampling it was determined that all of the soil above NMOCD RRAL's for TPH, BTEX, and Chloride was removed. The surface owner subsequently backfilled the excavation.

On behalf of Pyote Water Solutions, LLC we request that no further actions be required and that closure with regard to the release be granted.
