OCD has reviewed the Conestoga-Rovers & Associates' report regarding the above referenced release. OCD is in agreement with the report and will require no further action at this time. It is OCD's understanding that the facility has been expanded and now has equipment placed over impacted areas identified in 2010. It will be noted that it appears elevated hydrocarbon levels may have been left in place in areas identified as "N8 W88", "SS4" and "SS9". The report and final C-141 will be imaged to RP-3458, with the C-141 also imaged to the Skelly 940 well file. Federal sites will require BLM approval as well.
