13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. Failure of the flow line from the well to the battery occurred causing a release of crude oil and produced water. An approximate area of 80' X 10' was affected on the southwest corner of the well pad. Vacuum trucks were called to remove standing fluid, and impacted soil were removed and taken to an NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 0) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL a work plan will be submitted to the OCD. Depth to Ground Water: >100' (approximately 250', Section 6, T19S-R25E, per NMOSE), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Remediation completed according to NMOCD approved Work Plan. Yates Petroleum Corporation requests closure.
