Vernon,

I do not believe that 2RP-3427 is the correct incident report for this release. 2RP-3427 is around the pump and is already being addressed by a different environmental contractor. I believe the correct incident is 2RP-2342. This release resulted from a leak in the liner and affected the south side of the pad. I have attached the Initial C-141 for 2RP-2342 for your reference. Please consult with Devon to see if you concur.

That said, your proposal to clean the affected area is approved. Like approval by BLM is required.
