Dara - This just came in (though 4 weeks after-the-fact), so we did not discuss it. However, Oxy does have a R/W [NM-101331] for the SWD facilities. So I guess it is mine to handle.

Ms Purvis - and please forward this to the applicable Oxy staff -
You must submit a remediation plan to me for my approval.

I note that this facility has had several leaks through the years. Therefore please include in your remediation plan a discussion of why Oxy has had so many equipment failures at this location, and what replacements or rebuilding Oxy will propose to prevent any further such occurrences.

I notify Oxy at this time that further leaks or spills will place your R/W grant in a state of noncompliance, which may result in future termination of the R/W grant.

I am available to meet with you or with Oxy staff on site or elsewhere to discuss this issue.
